# **OUR IDEAL CANDIDATE**

To be successful in this role, you will demonstrate experience in overseeing WHS construction related activity in an operational public facility. You will need to have strong construction knowledge and a detailed understanding of construction processes, including the WHS obligations of contractors, and an understanding of construction related activity that can be undertaken by staff within an operational facility. You will need to demonstrate a commitment and ability to effectively promote a culture of safety and continuous improvement across a diverse organisation and in accordance with relevant legislation, policies and procedures.

You will require a commitment to customer service principles and practices with highly developed written and verbal communication skills, along with the ability to liaise and negotiate effectively with a broad range of stakeholders. You have highly developed organisational skills using technology to support your day to day activities.

You apply good judgement to high risk and complex matters and have demonstrated experience in ensuring that an organisation meets their 'Person Conducting a Business or Undertaking' (PCBU) and duty of care obligations as required under WHS legislation by:

• being accountable and taking ownership of health and safety matters within your control and promoting a culture of health and safety within an organisation, and

 working with colleagues to enhance health and safety to ensure that it becomes a part of everyday business.

### WHAT WILL YOU DO

In accordance with the NGA 6 work level standards and working to the Capital Works Taskforce Project Director you will have the following key responsibilities:

- 1. Through an innovative and proactive approach, promote and support a health and safety culture across the Gallery, with a focus on construction related activity undertaken by head contractors, facility management staff, other areas across the Gallery, and trade contractors. Through education and awareness-raising you will instil a sense of direction and inspire engagement with workplace wellbeing and safety.
- 2. Liaise, build and maintain effective working relationships with key internal and external stakeholders including head contractors, subcontractors, staff; managers/supervisors; and the Business Enabling Services Human Resources area who are responsible for the Gallery's WHSMS.
- 3. Maintain and implement the Gallery's WHS operational framework and operations manual for construction related activity, including appropriate controls and risk minimisation strategies, and processes for assurance and monitoring.
- 4. Research, interpret and apply technical knowledge to manage and monitor construction related activity WHS and develop strategic advice to enable the Gallery to meet its obligations under the WHS Act. This includes, but not - limited to the WHS induction of contractors and staff, the review of WHS documentation, auditing of contractors, site inspections and surveillance of staff undertaking construction related activity.
- 5. Prepare and review reports (including governance committee papers), briefing material, consultation, communication and assurance activities that support the management and implementation of the Gallery's WHS operations framework and manual for construction related activity.

#### WHO ARE WE LOOKING FOR

To be successful in this role you will need to be an experienced WHS professional with demonstrated capabilities, or have the ability to develop the following:

- Proven ability to support a culture of safety and continuous improvement, taking a proactive approach to building and maintaining WHS management systems for construction related activity, and their implementation including through promotion of better practice and a positive working environment.
- 2. The ability to be innovative to **achieve results** through the implementation of initiatives in the areas of WHS management, risk management, WHS reporting, and continuous improvement.
- 3. Highly developed interpersonal skills and a demonstrated ability to **build and maintain effective working relationships** across the Gallery, staff and construction related contractors and broader networks including other agencies, auditors and service providers.
- 4. High level **written and oral communication skills** tailored to diverse audiences and an ability to present and advocate on behalf of the Gallery.
- 5. Strong **personal drive and sense of integrity**, including professionalism, flexibility, resilience and self-awareness demonstrated through the exercise of sound judgement, discretion and problem-solving abilities coupled with capacity to manage competing priorities.
- 6. Relevant qualifications in WHS and demonstrated experience managing construction safety in an operational environment.
