# **OVERVIEW OF THE ROLE**

Working closely with the Public Programs Manager, the Public Programs Convenor collaborates with artists, curators, program convenors, content producers, program partners and communities to deliver public programs that promote national engagement with the National Gallery collection and exhibitions program. The Public Programs Convenor produces inclusive and accessible programs for diverse audiences that widen participation, spark curiosity and inspire new ways of thinking.

The Public Programs Convenor works closely with First Nations colleagues across the National Gallery to elevate the voices of First Nations artists and build knowledge and understanding of First Nations arts practices, cultures and perspectives.

The Public Programs Convenor is responsible for all aspects of program delivery including: project timelines; artist and speaker management; risk management processes; ticketing; website communication; budgets and supervision of casual and contracted event staff. You have demonstrated experience in programming events that are accessible and inclusive.

You hold a tertiary qualifications in visual art/art history or relevant qualifications in a cultural field. You also, share the Gallery's commitment to elevating the voices of First Nations artists and are experienced in collaborating with First Nations artists, curators and communities.

You are skilled in project management, including knowledge of budget processes and risk management. You have a proven record of delivering projects on time and in budget. You have experience writing and publishing web copy and understand online ticketing processes.

You will have an understanding and awareness of evaluation methods, with a commitment to reflective practice. Your experience in the supervision of casual and consultant event staff will be to your advantage.

- 1. Develop and deliver accessible and inclusive public programs for diverse adult audiences through collaboration with artists, curators, program convenors, content producers, program partners and communities.
- 2. Undertake all aspects of program delivery, including: project timelines; artist and speaker management; risk management processes; ticketing; website communication; budgets and supervision of casual and contracted event staff.
- 3. Supervise casual event staff and consultants.
- 4. Support key stakeholder relationships with external program partners and community networks nationally.
- 5. Undertake evaluation and participate in research that contributes to deeper understanding of audience needs and the impact and effectiveness of public programs.

- 3. **Communicate clearly** to present messages in a clear, concise and articulate manner. Focus on key points and use appropriate, unambiguous language. You will select the most appropriate medium for conveying information and structure written and oral communication to ensure clarity.
- 4. **Thinks strategically** to understand the work environment and initiate and develop team goals, strategies and work plans.
- 5. Apply and build professional expertise by valuing specialist expertise and capitalising on the knowledge and skills of others at the Gallery.
