### **OVERVIEW OF THE ROLE**

The National Gallery is undertaking a large change program consisting of an ambitious capital works program and a range of other significant delivery initiatives across all areas of the business.

This position is a hands-on role, responsible for providing accurate and timely accounting, financial analysis and reporting on the National Gallery's capital works program and projects. This includes working closely with the Senior Financial Analyst to provide effective accounting and financial management services to project stakeholders.

This is a full-time, non-ongoing employment opportunity available within the Financial Planning and Analysis Department. The position will be for an initial term of two-years, where a strong performer will have good opportunity for future career progression in the finance team.

The Financial Planning and Analysis Team is responsible for managing the National Gallery's strategic financial planning, analysing financial performance and income generating capability. Other key elements include financial management of commercial revenue streams, trusts and endowments, and capital projects with a focus on delivery of strategic analysis and advice to the National Gallery's senior management and Council.

#### **OUR IDEAL CANDIDATE**

To be successful in this role you will have professional qualifications, demonstrated experience in financial management and possess strong analytical skills and the ability to problem solve. You have excellent communication skills including the ability to communicate financial information to non-financial stakeholders and can work collaboratively to drive continuous improvement.

Your highly developed organisational skills, sound oral and written communication skills, ability to prioritise and excellent attention to detail will ensure you can lead and deliver high quality outcomes in a fast-paced environment.

Your self-motivated with the initiative and commitment to manage workloads and meet deadlines. You are client-focused and have excellent relationship management skills, applying sound judgement demonstrating integrity in all that you do.

### WHAT WILL YOU DO?

In accordance with APS 6 work level standards and with support of the Senior Financial Analyst, you will:

- Monitor performance against budget for capital projects and project reporting, including scrutinising project on-costs and internal charges.
- Produce accurate, relevant and timely monthly reports for capital projects including analysis that
  explains the financial results, performance against budget and trends. Assist the Senior Financial
  Analyst in the preparation of timely financial reports for the senior executive and the Council.
- 3. Liaise with the Capital Works Department on the preparation of project related spending proposals, including accurate financial information and timely approval by financial delegates.
- 4. At project completion aid in the completion of documentation to support asset capitalisation including review of financial data.
- 5. In conjunction with the Senior Financial Analyst provide advice to stakeholders on project financial management including suggesting improvements to financial management work practices.
- 6. Assist with the development of the annual and five-year capital budget including project cost analysis.
- 7. Assist with the development of the financial implication in relation to the acquisition of artwork including whole of life cost analysis.

Undertake other various ad-hoc finance duties commensurate with the skill and capability requirements at this level.

To be successful in this role you will need to demonstrate, or have the ability to develop the following,
